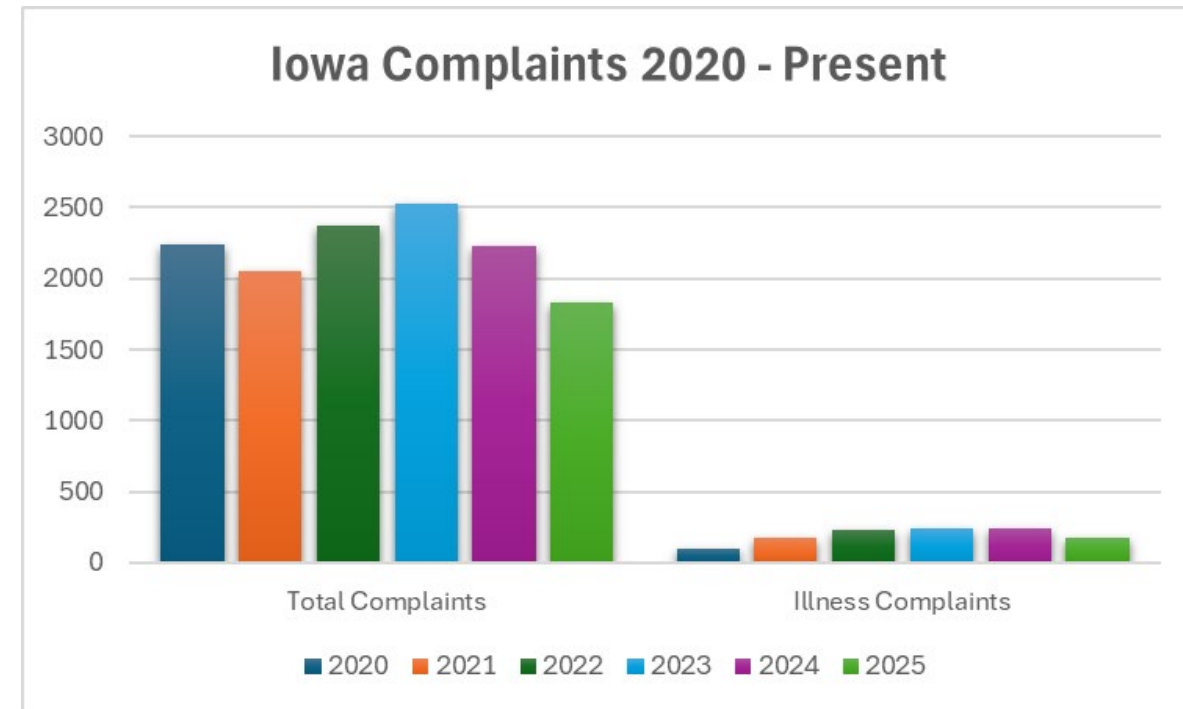

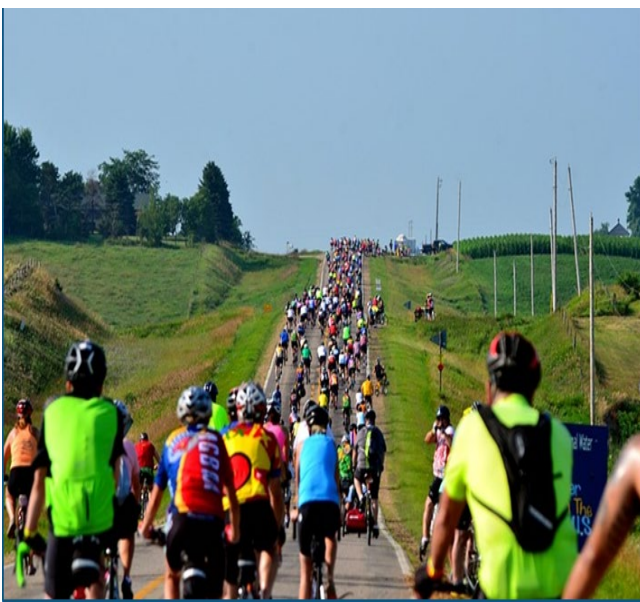


Incident Command System (ICS) Activation

Historic Flooding: Beginning in Northwestern Iowa

On June 21, 2024, a heavy rainfall caused flooding in several counties in Northwest Iowa. As the flooding progressed, counties along the Missouri River and surrounding areas were impacted. Iowa RRT activated ICS to respond and coordinate response between June 22-July 15, 2024. A Governor's proclamation was declared for 29 Iowa Counties.

Challenges included communication with Emergency Managers, limited access to the Web Emergency Operation Center, language barriers, and large scale response for available personnel. After Action Review (AAR) tasks identified: Ensure staff has access to State Emergency Web EOC, translate emergency guidance documents into other languages, and continue to work with Emergency Managers, Department of Natural Resources, and the American Red Cross to communicate during large scale events.

RAGBRAI

A significant response in 2024 included the 51st RAGBRAI, the Register's Annual Great Bicycle Ride Across Iowa, held on July 20-27, 2024. The event is an annual non-competitive bike race spanning West to East across the state. This event averages 468 miles for the entire route. The route for RAGBRAI 2024 included stops in 28 pass-through towns and 5 overnight meeting towns.

Iowa RRT activated ICS to respond and coordinate RAGBRAI on July 20-27, 2024. The Iowa Department of Inspections, Appeals, & Licensing (DIAL) utilized all 22 field staff inspectors to inspect the temporary food establishments throughout the event bike route, cover any complaints, illness outbreaks, and other emergency responses that occurred during the event and outside of the event response. DIAL completed 339 temporary food inspections during the event.

Challenges throughout the event included: communication, technology access, and enforcement out in the field. After Action Review (AAR) tasks identified: Explore options for communication with field staff while out in the field, training staff on ICS roles and ICS forms, and focus on enforcement procedure and guidance.

Highly Pathogenic Avian Influenza

Disaster proclamation was issued for Highly Pathogenic Avian Influenza (HPAI) for five Iowa counties: O'Brien, Palo Alto, Sac, Sioux, and Worth. The USDA had confirmed positive cases of HPAI in all five counties.

The proclamation allowed state resources from Iowa Homeland Security, the Iowa Department of Agriculture and Land Stewardship, along with other agencies to track and monitor, rapid detection, containment, disposal, and disinfection.

On December 20, 2024, The Iowa Department of Health and Human Services reported the first human case of avian influenza A (H5) in Iowa. The individual was exposed while working with commercial flocks in NW Iowa. There is currently no concern about the safety of eggs and poultry products or pasteurized milk and dairy products.

EF4 Tornado and Storm Response

On May 21, 2024, a significant weather event involving multiple storms, including a Derecho, tornadoes, flash flooding, and power outages impacted Iowa. Iowa RRT activated ICS to respond and coordinate response between May 22-31, 2024. A Governor's proclamation was declared for 45 Iowa Counties.

Challenges included lack of personnel, limited access to the Web Emergency Operation Center, and access to ICS fillable forms. After Action Review (AAR) task identified: create decision tree guidance documents to help inspectors make sound judgements or critical decisions after obtaining information on impacted areas.

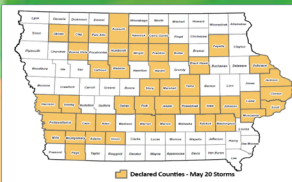


Figure 1. Map of impacted counties in Iowa.
